

MSBM Breakfast Potluck



Research on Caribbean MSMEs

Dr. Lawrence Nicholson's new book "Understanding the Caribbean Enterprise: Insights from MSMEs and Family-Owned Businesses", was featured in the Jamaica Observer in April 2017. Micro, Small, and Medium Enterprises (MSMEs), especially family-owned businesses (FOBs), account for about 70 per cent of private sector employment in the Caribbean. However, very little research exists about this sector in the region, leaving a wide vacuum for data needed to sustain the growth and development of the sector, which is so critical to the success of these Caribbean economies. Co-authored with Jonathan G. Lashley, and published by Palgrave Pivot last July, this book sheds some light on this previously unexplored area within the Caribbean.
